# Minutes of the Annual General Meeting Shuswap Theatre Society

Shuswap Theatre, 41 Hudson Ave. NW, Salmon Arm, BC September 24, 2013 7:00 p.m.

Chairperson Monica Kriese welcomed everyone to the meeting and called the meeting to order at 7:05 pm.

## **President's Report:**

Monica Kriese referred briefly to her report printed in the Annual Report highlighting the highs and lows experienced in the 2012/2013 season and thanking the outgoing board members for their dedication and efforts toward the growth of the theatre during the past year.

## **Financial Report:**

In her report Treasurer/Accountant Sue Simmonds stated that revenue for the year came mostly from grants, that ticket sales were lower than anticipated, that the Investor Savings Account was looking good and that expenditures had been kept within range of what was expected.

In Sue's absence Monica explained the details of the line of credit, the mortgage to the City and the student grant for Kenthen Thomas. Kim MacMillan then voiced thanks to Sue for her excellent work as treasurer.

Monica then outlined the proposed budget, answering questions put forth by attending members.

Scene Shop/Construction – Randy Brogden – no additional information/questions. Building/Lighting/Sound – Jake Jacobson – no questions.

Building Committee – Jake Jacobson – outlines report, special meeting, member feedback (in report and in progress).

## **Proposed Increase in Size of Board:**

## **Special Speaker:**

Monica introduced Michelle Ambrose of Michelle Ambrose Consulting whose theme was "Shaping the Future of Your Theatre"; a continuation of the member focus groups and feedback gathered in the previous months. Michelle spoke briefly her business and the exercise she wished to introduce this evening, inviting everyone present to take part. Small groups were then formed to answer two questions to do with the theatre, namely:

- 1.) In order to achieve our vision, what is the Shuswap Theatre currently doing well and should KEEP doing?
- 2.) In order to achieve our vision, what should the Shuswap Theatre START doing?

Participants were asked to keep in mind that Shuswap Theatre's vision is..."To enrich the lives of community and theatre members through diverse and inspiring live entertainment." These questions initiated much lively discussion and produced a lengthy and diverse list of feedback for Michelle and the Board to summarize.
