ARTISTIC & PRODUCTION

- Artistic Committee Christmas show Co-Production between Shuswap Theatre & Salmon Arm Secondary. Gloria briefed Board on the plot of the Xmas Show – Santa's Zombie Apocalypse – see attached report from Artistic Committee. Peter and Hammy attended Artistic Committee Meeting and agreed on Co-Production, a collaboration between Shuswap Theatre and Salmon Arm Secondary.
- Hammy read email from Susan McMillan regarding availability of enough crew to cover the show and some questions about ticket price for the show.
- Hammy has presented the listing of jobs split between Shuswap Theatre & Salmon Arm Secondary. Gloria to direct and Hammy will produce. Media elements of the show will be done via PowerPoint and Kim will assist. Hammy had positive response from Hayden Clayton, and Claire Hall, & Liz Kingdom will cover front of house with young ushers from the Leadership Program at Salmon Arm Secondary, Joyce to fundraise. Double Cast Grades 11/12 each cast 24 people performing alternating shows. Hammy included proposed production budget, \$10 tickets, breakeven 48% & 75 each making about \$1,800 collect all monies then reimburse expenses and then split the remaining. Tracy moved to move forward with Coproduction for Xmas show seconded by Sherry. Julia mentioned the critical shortage of Stage Managers & Directors. See Artistic Committee Report attached. Julia confirmed Frank sent Hammy AGM report.

- Devon More Flute Loops, August 31, update- Sold out show and standing ovation Devon received about \$1,245 as per her share of the box office.
